

# Awards of Distinction



## ***What are the ISA Awards of Distinction?***

The ISA Awards of Distinction are recognized as the highest honors bestowed by ISA. Award recipients are selected from nominations submitted by members and industry professionals and are recognized for lifetime achievements, arboricultural education and research, bodies of work, and contributions to practical arboriculture or to ISA. Nominations are reviewed by the Awards Committee which recommends selections for each award category. The recipients are approved by the ISA Board of Directors and announced at the ISA Annual International Conference.

## ***What are the benefits of receiving an Award of Distinction?***

Recipients are honored at the Opening Ceremony of the ISA Annual International Conference, followed by recognition throughout the tree care industry through news releases, articles in ISA publications such as *ISA Today* and *Arborist News*, the ISA website, and social media. Award winners also receive extensive public exposure through national or international press releases and advertisement in their local newspapers.

**AWARD OF MERIT** is the highest honor ISA bestows, recognizing a career of outstanding, meritorious service in advancing the principles, ideals, and practices of arboriculture. Granted only to members of ISA.

**ALEX L. SHIGO AWARD FOR EXCELLENCE IN ARBORICULTURAL EDUCATION** recognizes the important role that all forms of education play in enhancing the quality and professionalism of the arboriculture industry. Granted only to ISA members in recognition of sustained excellence in arboricultural education.

**SHARON J. LILLY AWARD OF ACHIEVEMENT** is granted only to ISA members in recognition of sustained, outstanding effort or contribution to the advancement of the International Society of Arboriculture.

**HONORARY LIFE MEMBERSHIP** is granted to members of ISA who have contributed materially and substantially to the progress of arboriculture and have given unselfishly in their efforts to support arboriculture. Honorary Life recipients are given complimentary ISA membership for their lifetime. (This membership is non-transferable.)

**R. W. HARRIS AUTHOR'S CITATION** is granted to authors for sustained excellence in the publication of timely information pertaining to the field of arboriculture.

**L.C. CHADWICK AWARD FOR ARBORICULTURAL RESEARCH** is granted to individuals in recognition of their research that has contributed valuable information to arboriculture.

**MILLARD F. BLAIR AWARD FOR EXCEPTIONAL CONTRIBUTION TO PRACTICAL ARBORICULTURE** is granted in recognition of service that has made a substantial contribution to practical arboriculture.

**EARLY-CAREER SCIENTIST AWARD** is granted to individuals who show exceptional promise in the arboriculture industry with high potential to become internationally-recognized scientists.

**HONORARY MEMBERSHIP** recognizes individuals who are NOT ISA members, but who have demonstrated continued interest and outstanding service in the advancement of arboriculture through research, field practice, promotion, invention, or literature. Honorary recipients are given a complimentary 12-month ISA membership.
